RESOLUTION NO. 22-06
Director District Redistricting (RCW 28A.343.040)

A RESOLUTION of the Board of Directors of Arlington Public Schools No. 16, Snohomish County, Arlington, Washington, changing the boundaries of its Director Districts using 2020 US Census data.

WHEREAS, Arlington Public Schools received 2020 Census data on September 16, 2021 from the United States Census Bureau.

WHEREAS, Arlington Public Schools enlisted the services of Flo-Analytics of Portland, Oregon to analyze and recommend new boundaries based upon 2020 US Census data.

WHEREAS, the Arlington Public Schools staff and Board followed Board Policy 1105.

WHEREAS, The Arlington Public Schools staff and Board followed Procedure 1105P, thus fulfilling the requirements of RCW 29.070.100.

WHEREAS, The Arlington School Board held a Public Hearing on May 23, 2022 to present recommended boundary changes, and received no public comment.

WHEREAS, Flo-Analytics provided a legal description on June 13, 2022 of the Director District Boundaries as presented in the May 23, 2022 Public Hearing.

NOW, THEREFORE, BE IT RESOLVED, that the Arlington Public Schools Board of Directors is establishing new Director District Boundaries. These revised boundaries are described as follows:

Director District 1

Starting at the intersection of South Fork Stillaguamish River and Stillaguamish River.

Northwest on South Fork Stillaguamish River to Stillaguamish River.

West on Stillaguamish River to Hwy 9.

Northerly on Hwy 9 to Harvey Creek Rd (Old Hwy 9).

Northerly on Harvey Creek Rd to Lake Armstrong Rd.

Easterly on Lake Armstrong Rd to Mose Rd.

Northeasterly on Mose Rd to the southern boundary of T32N R5E Section 25.

West on T32N R5E Section 25 2,162ft to western boundary of Census block 530610534003021.

Northerly on Census block 530610534003021 to Kunde Rd.

West on Kunde Rd to transmission line.

North on transmission line to Grandview Rd.

Westerly on Grandview Rd to 75th Ave NE.

Northerly on 75th Ave NE and extension to transmission line.

Northerly on transmission line to School District boundary.

Clockwise following School District boundary to the South Fork Stillaguamish River.

Northwesterly on South Fork Stillaguamish River to the intersection of the western boundary of T31N R6E Section 7 and transmission line.

South on transmission line to Moran Rd.

Westerly on Moran Rd to Tveit Rd.

Westerly on Tveit Rd 4,193ft to City of Arlington city limit boundary.
North on city limit boundary to the northern boundary of T31N R5E Section 12.
West on T31N R5E Section 12 880ft to City of Arlington city limit boundary.
Northerly on city limit to southwestern boundary of Census block 530610535103000.
Northwesterly on Census block 530610535103000 to E Division St.
Westerly on E Division St to N Manhattan Ave.
North on N Manhattan Ave to Burke Ave.
Easterly on Burke Ave to the to the point of the beginning.

South from the point to the intersection of the City of Arlington city limit boundary and Tveit Rd.
West on Tveit Rd to E Highland Dr.
West on E Highland Dr to S Dunham Ave.
North on S Dunham Ave to Jackson St.
West on Jackson St to S MacLeod Ave.
North on S MacLeod Ave to Union St.
West on Union St to S Olympic Ave.
North on S Olympic Ave to Maple St.
Westerly on Maple St to Hwy 9.
North on Hwy 9 to S West Ave.

Easterly on Lake Armstrong Rd to Mose Rd.
Northeasterly on Mose Rd to the southern boundary of T32N R5E Section 25.
West on T32N R5E Section 25 2,162ft to western boundary of Census block 530610534003021.
Northerly on Census block 530610534003021 to Kunde Rd.
West on Kunde Rd to transmission line.

North on transmission line to Grandview Rd.
Westerly on Grandview Rd to 75th Ave NE.
Northerly on 75th Ave NE and extension to transmission line.
Northerly on transmission line to School District boundary.
Counterclockwise following School District boundary to the intersection of 200th St NE and I-5.
East on 200th St NE to Smokey Point Blvd.
Northerly on Smokey Point Blvd to the southern boundary of Census block 530610535081011.
Easterly on Census block 530610535081011 to the eastern boundary of Census block 530610535081011.
North on Census block 530610535081011 to the point of the beginning.

Director District 4

Northeast on Woodbine Dr to Whitehawk Dr.
Northeast on Whitehawk Dr to Newport Dr.
Southeast on Newport Dr to Eaglefield Dr.
Northeast on Eaglefield Dr to Hwy 9.
South on Hwy 9 to 160th St.
East on 160th St to 91st Ave.
North on 91st Ave to 164th St.
East 3,772ft to a point on 164th St.
Southeast from the point to the intersection of Portage Creek and 160th St NE.
Easterly on 160th St NE to McElroy Rd.
South on McElroy Rd to the southern boundary of T31N R6E Section 31.
Easterly on T31N R6E Section 31 to School District boundary.
Counterclockwise following School District boundary to South Fork Stillaguamish River.
Northwesterly on South Fork Stillaguamish River to the intersection of the western boundary of T31N R6E Section 7 and transmission line.
South on transmission line to Moran Rd.
Westerly on Moran Rd to Tveit Rd.
Northwesterly on Tveit Rd to E Highland Dr.
West on E Highland Dr to S Dunham Ave.
North on S Dunham Ave to Jackson St.
West on Jackson St to S MacLeod Ave.
North on MacLeod Ave to Union St.

East on T31N R6E Section 31 to School District boundary.
Clockwise following School District boundary to final crossing to 67th Ave NE.
North on 67th Ave NE to the point of the beginning.
